

Emerging Filmmakers Grant Program

Overview

The Film Lauderdale Emerging Filmmakers Grant seeks to provide a funding resource to Broward County-based filmmakers to produce individual projects. Eligibility is based on Broward County-centric criteria and professionalism of the presentation. After an application has been approved, a grant of \$10,000 will be distributed in three payments (subject to appropriation each fiscal year) after meeting all required criteria in phases of production (see Grant Payment Schedule).

Eligibility / Requirements

- Potential applicants must submit their resume and description of the project to the Film Commission prior to applying for an initial review of project eligibility.
- A project must be either a Production or a Digital Media Project, as defined below.
- Applicants must provide proof of at least six (6) months of residency in Broward County. Two forms of proof are required.
- All funds from the \$10,000 grant must be utilized in Broward County on Qualifying Payroll and Qualifying Expenditures.
- Matching funds (totaling \$10,000) are required, and proof of the available funds must be provided with the initial application submission along with the full budget. Proof may come in the form of a bank statement, proof of present grant award (non-Broward County grants only), or guarantee from financial institution/film fund/loan company. Proof of funding from outside sources must come with a notarized authorization letter from investor / funding entity. ***NOTE: Given that the grant is for \$10,000 and applicants are required to provide proof of matching funds of \$10,000, the total project budget must meet or exceed \$20,000 total.*
- Applicants can apply every other year with a maximum of two grant agreements approved per individual for the lifetime of the program.
- The Emerging Filmmaker's grant cannot be combined with any other Film Lauderdale incentive program.
- The applicant must be a practicing professional filmmaker (director, producer, or writer) who in the past three (3) years has created a body of original film(s) and has received distribution or acceptance into a major film festival, as defined below. A resume/CV, proof of distribution, and examples of past and current work are required

to support this claim. Additionally, if the applicant is a director or writer, they must show proof that a producer is attached to the project.

- A completed script, story synopsis, and filming schedule must be submitted with the application.
- 80% of the Production Days must be filmed in Broward County.
- 70% of Cast and Crew must be Broward County residents. *NOTE: required cast and crew percentage may not include background talent, but if they are Broward County residents, their salaries count towards eligible expenditures.*
- 50% of vendors must be Broward County businesses and (15%) of those Broward County businesses must be County Business Enterprise / Small Business Enterprise (CBE/SBE) (or best efforts must be made with assistance from the Film Commission to hire CBE/SBE's registered with the Office of Economic and Small Business Development).
- Grantees must submit their intended crew/cast hires with associated residential addresses, as well as list of locations, at least ten (10) business days prior to commencing principal photography so that the Film Commission can ensure the necessary steps are being taken to meet the program's percentage requirements.
- Broward County logo must be included in the credits.
- Promotional stills and marketing materials must be provided prior to the release of the production project to the Film Commission for use on their website and other marketing efforts.
- Grantees must provide plans for project distribution (film festivals, screenings, agreements with networks/streaming platforms, etc) for project tracking and promotional purposes.

Definitions

Cast and Crew means personnel hired on a Production Project who work as talent in front of the camera or in the technical and practical business of shooting a Production.

County Business Enterprise / Small Business Enterprise (CBE/SBE) means the definition of CBE and SBE in Ord. No. 2012-33, Section 1-81.2, Broward County Code of Ordinances.

Digital Media Project means visual effects or digital animation sequences.

Emerging Filmmaker means a new or up-and-coming filmmaker who is early in their career, often bringing fresh perspectives and innovative storytelling to the industry.

Production means a theatrical or direct-to-video motion picture; a made-for-television motion picture; visual effects or digital animation sequences produced in conjunction with a motion picture; a short film; a documentary film; a television pilot program; a presentation for a television pilot program; a television series or streaming, including, but not limited to, a drama, a comedy, a soap opera, a telenovela, or a miniseries production. One season of a television series is considered one production.

Production Days means the combined number of days used to create a Production, including pre-production, days spent on-site making the Production, and post-filming days, which includes the preparation concluding a Production as well as editing a Production to achieve a final product.

Production Project means an eligible Production or Digital Media Project.

Qualifying Expenditures means payment for such goods and services and labor per requirements from the date of submission of the application through the Duration of Project (as defined below). A list of eligible expenditures is available upon request from the Film Commission. Proof of Broward County residency requires a copy of a Florida driver's license and one (1) other supporting document (which is dated within one month before pre-production through one month after wrap). Qualifying Payroll means payment of salary to Broward County residents for work performed from the first day of pre-production to the last day of post-production ("Duration of Project"), excluding salary in excess of \$2,000 for any Broward County resident.

Application Process

A qualifying application and required accompanying paperwork must be completed in full and submitted via email to the Broward County Film Commission prior to principal photography. Emailed documents must be submitted in PDF form. The only email address where applications may be submitted is Film@FilmLauderdale.org. If by USPS please send to:

Upon submission of the application, the applicant will receive by email a confirmation message acknowledging receipt of the application. The application and required paperwork will be reviewed for accuracy and will be vetted.

Each Production Project must start principal photography within 120 days after application submission. The finished project must be presented within 180 days of production start date. At Film Commission's discretion, one reasonable extension to deliver finished project can be granted if there are extenuating circumstances.

Incomplete applications and paperwork will NOT be accepted. Application package is only considered complete when all required documents have been received.

*Note to applicant: All documents related to the Incentive Agreement, including but not limited to all exhibits, the application, audit results, financial documents, and certificates of insurance are public records and subject to Chapter 119, Florida Statutes. **No paperwork that has personal information, including and not limited to Social Security numbers, medical records, etc. will be accepted. All personal information must be redacted.***

If any project is not completed after any phase of the grant being awarded, the applicant will no longer be eligible for future Broward County Emerging Filmmakers Grants (or other Broward County grant opportunities) in perpetuity and could be subject to legal recourse.

Applicants cannot apply to any other Broward County Screen Incentive Program options per each individual project.

Grant Approval Process

After an application has been submitted and all paperwork has been reviewed for eligibility, professionalism of the presentation, and additional vetting, the application will be presented to the Film Commissioner. If application is approved by the Film Commissioner, then an official written notice will be sent to the applicant and an agreement will be prepared for grantee signature.

Grant Payment Schedule

- Payment One (1) \$3333.33: Upon submission of proof of production (i.e., production calendar, issued permits, call sheets, behind-the-scenes set stills, etc.) showing 80% of production days were filmed in Broward, AND proof of 70% Broward cast/crew hires (must provide residency forms with driver's license and 2nd proof of residency).

- Payment Two (2) \$3333.33: Upon submission of proof of payments to all cast, crew and vendor associated with the production and confirming that 70% of the cast and crew paid were Broward residents and 50% paid vendors were Broward County-based businesses.
- Payment Three (3) \$3333.33: Upon submission of completed project showing the Broward County designated logo in the credits and providing marketing materials (i.e., movie poster, social media promotion, marketing images, etc.)

Public Records

All documents related to the Incentive Agreement, including but not limited to all exhibits, the application, audit results, financial documents, and certificates of insurance are public records and subject to Chapter 119, Florida Statutes.

- Resume/CV, and examples of past and current work (supporting the requirement that applicant must be a practicing professional filmmaker with at least 3 years of original work which has received distribution or acceptance into a major film festival)
